The temperature checks are happening, however the most recent records were not available. School will add this to the caretaker daily checks and records kept in separate folder in future.	24/02/2024

0069485	Asbestos - Training? It is a legal requirement to ensure that training is provided to those employees who may, in the course of their duties be more likely than others to be exposed to asbestos and also train those "controllers" who commission others who by the nature of the work to be carried out would similarly be at enhanced risk of exposure. For example, Headteacher, Caretaker, Site Manager etc. Asbestos awareness e-learning has been undertaken by the Executive Headteacher and Caretaker, however, the one day Asbestos Awareness and Duty to Manage course will ensure compliance with legislation. It is recommended that the school asks for those assessments to be reviewed to ensure that they are site specific as well as reference being made to AfPE, etc.
